The resource activity is proposed to occur on the following tenures: ATP2012, ATP526, PL100, PL1017, PL232, PL233, PL234, PL235, PL236, PL420, PL421, PL440, PL90, PL91, PL92, PL99, PPL76 and PPL92. These tenures cover an area of approximately 3,415 km², and are located approximately 18 km east of Injune and 30 km north-east of Rolleston in the Maranoa, Central Highlands and Banana Shire council areas.

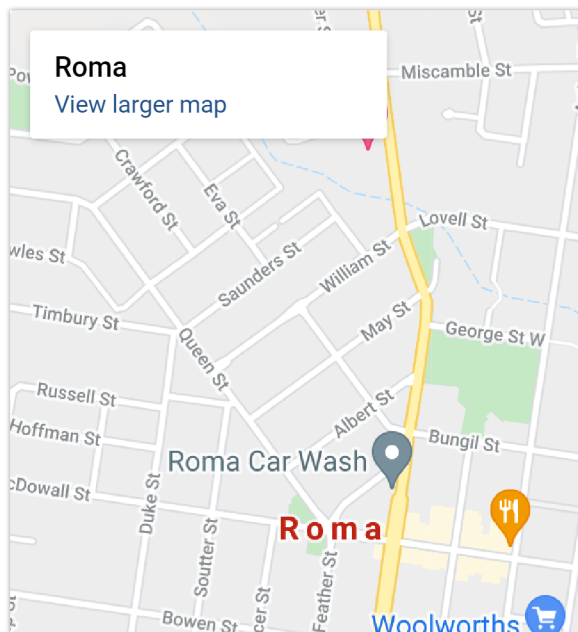
